# MIDDLESEX COUNTY CRAFT FESTIVAL RULES, REGULATIONS & CONDITIONS OF VENDOR AGREEMENT

Please Read Carefully and Sign where Required\*

- 1. All vendor fees are non-refundable-NO EXCEPTIONS
- 2. Should this event need to be rescheduled for reasons beyond our control; you agree that you will be provided a rescheduled date option, should you not be able to make the rescheduled date; a credit to use for future events by Middlesex Shopping Extravaganza Events will be applied and you will be notified of terms and expiry of that credit via email communication
- 3. All vendors are required to handle your own sales tax if applicable\*, have their own cash/change on hand as well as a reliable internet connection for payments such as Square, Intuit etc.
- **4.** We will NOT hold spaces, you need to complete form and send in EMT, once EMT is accepted; that is confirmation you are registered\*
- 5. Vendors are required to have their own professional/creative signage and provide their own table, chairs, tents, linens and must have hand sanitizer present where payment is taken. Proper face coverings are required\*
- **6.** You agree to allow Middlesex Shopping Extravaganza to list, market and take photos from your social media pages as well as photograph vendor space during event and use for social media, website/marketing purposes
- 7. As a vendor you agree to share this event through social media/marketing and showcase your designated "Vendor Badge" photo as your profile photo and or cover photo on Facebook
- 8. Vendors agree to provide their own tent/canopy for their OUTDOOR VENDOR SPACE
- 9. Chairs and tables are NOT provided; Vendors agree to bring their own
- **10.** All outdoor structures must be able to withstand any inclement weather conditions, be fastened down and pose no harm or danger to life or health
- **11.** Vendor Space is exclusively for the applied and approved vendor. Sharing of vendor space is prohibited; any other changes must be approved by Jennifer Pratt in writing for approvals
- **12.** Vendors agree to keep their spaces neat and tidy, walking areas clear of loose cords, high stacked items, sharp objects that can be grabbed by children etc. which can potentially cause harm or risk to vendors or attendees.
- 13. No open flames; or Campfires
- **14.** Extension cords are not provided, all vendors to provide their own if required. Must meet Canadian Safety Standard Rules & Regulations
- 15. NO SMOKING on Grounds; All Ilderton Fairgrounds Property is designated as a NON-SMOKING area
- **16.** No Bulk water containers to be filled on grounds.
- 17. No Trailer-Water Hook Ups are available or close by
- **18.** Vendor placement will be selected by Middlesex Shopping Extravaganza Events. Placement is final, please always respect your neighbours
- **19.** *Electrical is only designated in certain areas.* Electrical is only available to those who required and paid for outlet use
- **20.** All Vendors are required to stay right until the end of the designated time of event, No take downs. Please ensure you respect other vendors, attendees and safety of all participants and visitors. Failure to do so will result in loss of future event participation with Middlesex Shopping Extravaganza Events
- **21.** Middlesex Shopping Extravaganza Events agrees to secure premise overnight with a third-party hired security company on the Friday and Saturday for vendors to leave booths setup and covered

- **22.** Vendor must remove and dispose of all garbage in their areas at the end of the show, please recycle and bring necessary bags/bins, if necessary, Please do your part.
- 23. Vendor vehicles are prohibited on event space and to be driven on vendor grounds on Saturday August 21<sup>st</sup> & Sunday August 22nd, 2021, after 9AM on Saturday and Sunday. Vendors are required to part where designated-Absolutely no cars by vendor tents or on grounds. This has been a past safety issue and will be enforced this year.

- Vendors are required to be FULLY setup and ready for attendees by 9:30AM as we often get the early comers. This is a great rule of thumb to go by.
